

### A Word from the Director

During the past year, we have worked to make the John H. Schnatter Center for Free Enterprise accessible to even more members of the university and community at large. We endeavored to attract university attendees from all programs and schools by offering speakers and topics that would appeal to a wide range of interests. For example, our Fall Speaker Series, *Asia: From Communism to Capitalism* brought attendees from Asian Studies, Political Science, and a number of other programs. Likewise, our spring offerings appealed to a number of diverse audiences, as we recognized Black History Month with speaker Star Parker, and Women's History Month with a panel of successful female entrepreneurs.

We made significant inroads into the local business community by hosting discussion forums featuring current topics of interest and experts on those topics. Our "What Stymies Business in Kentucky" panel offered local business people the opportunity to engage with policy experts about the regulations that inhibit progress in Kentucky. The distinguished panel included John Allison, former CATO exec and retired BB&T Chairman/CEO, along with James Broughel from Mercatus Center and Jordan Harris and Josh Crawford from Pegasus Institute.

While Bob Luddy was in town for our Spring Speaker Series on Entrepreneurship, we hosted a panel discussion on school choice in Kentucky, a topic of local and national interest. In addition to Luddy, who is passionate about school choice, the panel included Jordan Harris from Pegasus Institute and Joel Adams with Kentucky Charter School Project. This panel stimulated impassioned discussion from both sides of the issue.

We at the Schnatter Center are proud to offer programming and events that students can't get elsewhere on campus. We look forward to encouraging conversation and debate on topics that affect us all. After all, this free exchange of ideas is what makes a student well-rounded and best prepared for life after college.



# Special Events



North Korean defector Yeonmi Park captivated a standing-room-only audience with her story of survival and triumph. She spoke of the horrors of growing up under the Kim regime and escaping North Korea as a young teenager. The crowd of 450 included students, faculty and staff of the university, as well as members of the community.



Dr. Frank Dikötter spoke to a packed house about his research on China's Mao era. His compelling talk was based on his book that detailed recently-opened Chinese archives, classified documents, secret police reports and eyewitness accounts of the atrocities that took place under Mao Zedong.



In November, we hosted Dr. Ning Wang, who discussed China's transformation from a profoundly impoverished agrarian economy to the economic powerhouse it has become. Dr. Wang's talk to a full house of 225, was based on the award-wining book he co-authored with Nobel Prize winning economist Ronald Coase. Prior to his talk, Dr. Wang met with College of Business faculty for a luncheon discussion.

ADAM SMITH NOVEMBER 16, 2016 Adam Smith spoke to the student reading group of 20 that read his book, *Bootleggers & Baptists*. He also met with faculty and spoke to the Econ 375-Capitalism and Economic Freedom class during his visit.

STAR PARKER FEBRUARY 9, 2017

Star Parker gave a passionate talk about her journey as an entrepreneur. The founder and president of the Center for Urban Renewal and Education (CURE) told the audience of 225 how our country's leaders and legislators must do more to stand up for free enterprise and small business, not create laws that discourage entrepreneurship and opportunity.



Entrepreneur Bob Luddy, Founder and President of CaptiveAire Systems, spoke to a crowd of 220 attendees about the importance of creating value, and why entrepreneurs must serve the user. Luddy shared stories from his own career, speaking about how his focus on ongoing improvement and innovation helped him build a successful business.

Led by panel members Bob Luddy, Joel Adams (KY Charter School Project) and Jordan Harris (Pegasus Institute), the discussion ranged from the current state of school systems in Kentucky to charter schools and low-cost private schools. The audience kept the conversation flowing with great discussion.

This panel discussed entrepreneurship from both the entrepreneur's and the investor's perspective. Moderated by Suzanne Bergmeister (Assistant Director, UofL's Forcht Center for Entrepreneurship), it featured Christina Bechhold (Principal, Samsung NEXT Ventures) and Jennifer Williams (Founder/CEO, Cuddle Clones). The discussion included information on what makes an investor say "yes" or "no" to an opportunity, and why someone in a comfortable corporate position would risk it all to make the entrepreneurial leap.

# Looking Ahead

During the upcoming year, we will continue to offer prominent speakers to our students and the community, as well as establish new programs to broaden our reach.

In July, we will host the inaugural class of the Economics and Entrepreneurship Summer Program. We have accepted 38 high school juniors and seniors to participate in a



two-day program that will offer classroom instruction by UofL faculty, as well as guest speakers from the community. Each day will include a field trip off-campus. The concept of the program has been well-received by area high school teachers and counselors and will ideally lead to more engagement with this pool of potential students.



The anchor speaker for our Fall 2017 Speaker Series will be Steve Forbes. We are finalizing an additional high-profile speaker(s) for fall. During the spring we plan to host two large-scale speaker events. We will continue to sponsor student reading groups, as these have become very popular. We'll also be working with student groups, programs and faculty outside of the College of Business, and national organizations to offer movie nights, roundtable discussions, debates, and other forums for discussion throughout both semesters.
