### From the Director

Since its founding in August 2015, The Center for Free Enterprise has embarked on a mission of engaging in research and teaching that explores the role of enterprise and entrepreneurship in advancing the well-being of society. To that end, the Center has hosted dozens of events and programs reaching thousands of participants throughout the University and local community. This past year, we were able to engage with even more students, faculty, and community members by offering a variety of speakers and topics that appealed to a wide range of interests.

We kicked off the fall semester with our largest program to date. Along with the Young Americans for Freedom student group, we welcomed Steve Forbes to campus. More than 500 people from UofL and the community gathered to hear the business icon and one-time presidential candidate speak on

the nation's economy, healthcare, and the free market system.

In October, we held a symposium jointly sponsored with the Institute for Humane Studies called "Friends in High Places: Examining the effects of cronyism in society." This all-day event for 35 students included talks by professors Peter Calcagno, Steve Miller, and Steve Gohmann.

Our November headline event, "Kentucky's Bourbon Boom: A panel discussion on the economics of the bourbon industry," featured industry pros discussing Kentucky's favorite beverage. During the spring semester, we focused our programming on the criminal justice system at both the national and local level. A panel discussion on the problems facing the U.S. system was moderated by Michael Losavio from the UofL Criminal Justice Department. The Center co-sponsored the BB&T speaker series featuring author John Pfaff, who spoke on mass incarceration. And during National Criminal Justice Month, we hosted a panel discussion on crime issues specific to Louisville.

The Center has undertaken some new events to reach out to students (and students-to-be). In July, the Center hosted its inaugural Economics & Entrepreneurship Summer Program for high school students. Thirty-five rising juniors and seniors participated in the two-day event, which featured a mix of class time exploring economics, free enterprise, and entrepreneurship; exposure to the University campus; and off-site field trips to GE FirstBuild and Papa John's Corporate Headquarters. We also hosted a Movie Night, which brought in nearly 100 students to view and discuss "Freakonomics." The Center reading groups and colloquia are open to students in all majors, and as a result, attract participants from a wide variety of backgrounds, ages, and interests. This diversity encourages more interesting conversation from varying viewpoints.

As the Center continues to grow and evolve, we look forward to reaching even more students and community members with quality programming and research. I hope you enjoy looking back over the past year's activities, and encourage you to join us at one of our programs this fall, as we begin our fourth year at the University of Louisville College of Business.





NOVEMBER 15, 2017



Panelists Josh Crawford (public policy researcher with Pegasus Institute), Deborah Keeling (UofL professor of criminal justice), and Christopher 2x (community activist) provided research data and front-line insights on what is wrong with Louisville's criminal justice system and strategies to address the issues.









Thirty-five high school juniors and seniors participated in The Center's inaugural Economics & Entrepreneurship Summer Program last July.
